It is highly recommended to elect the three courses included in the Minor Accountancy, in preparation for the Master Accountancy - Auditing Track. If you decide to go study abroad during that Semester, but intend to do the Master Accountancy - Auditing Track, you are advised to look for equivalents for the three courses included in the Minor Accountancy. But ultimately, provided that you complete the Master Accountancy - Auditing Track, the three courses included in the Minor Accountancy will not be requirements for admission to the PMA or EPMA programs.

Unfortunately, at the moment, the bachelor course 324923 Voortgezet Boekhouden is no longer offered. As the subject matter of this course remains a requirement for students aspiring to become a registeraccountant, an equivalent course is offered to students that have registered for either the PMA or the EPMA program (so included in the PMA/EPMA programs).
