During your studies, you do a three-year traineeship in an audit firm. This traineeship includes some formal coursework, half-yearly trainee reports, a term paper in which you describe a dilemma that you encountered in practice, an internal control case from your own practice, and a final integrated oral exam. After successfully finishing the traineeship and the Post-Master Accountancy, you become listed in the charter of the NBA, and are allowed to bear the title Registered Accountant (RA).
