About the Speakers

Ziv Bohrer is a faculty member at Bar-Ilan University, Faculty of Law. His main areas of research are International Criminal Law and International Humanitarian Law. Currently he is conducting extensive research on the centuries-long, forgotten history of International Criminal Law.

Ilya Kotlyar is a post-doctoral researcher in Tilburg University for the project 'Coherence in Law Through Legal Scholarship' (CLLS), an ERC Starting Grant project. He defended a PhD (Law) on the influence of *Ius Commune* on the Scottish law of succession at the University of Edinburgh. His research focuses on the reception of Roman legal traditions in the history of medieval law.

Randall Lesaffer is professor of Legal History at Tilburg University and the University of Leuven. He is editor-in-chief of the book series 'Studies in the History of International Law', of the Oxford Historical Treaties, series editor of the Global Law Series (Cambridge University Press) and editor of the 'Journal of the History of International Law'. His current research interests include the history of international in its political context from 1500 to the present.

Emiliano J. Buis is an associate professor of public international law. He teaches both at a graduate and postgraduate levels at the University of Buenos Aires Law School, the Central University (UNICEN), and the School of National Defence. His main research interests include the law of armed conflicts, international humanitarian law, international law of disarmament, and the origins of international law in antiquity.

Yuko Nishitani is Professor of International Private and Business Law at Kyoto University Graduate School of Law in Japan since April 2015. Prior to this, she held a chair at Tohoku University (1997-2007) and Kyushu University (2011-2015). Her area of interests is private international law, international business law, international civil procedure law, comparative law, and family and succession law.

Ana Delic is a PhD researcher at Tilburg University. Her research centers on the development of private international law, international contract law, international civil procedural law, and comparative law from 1750 to the present.
